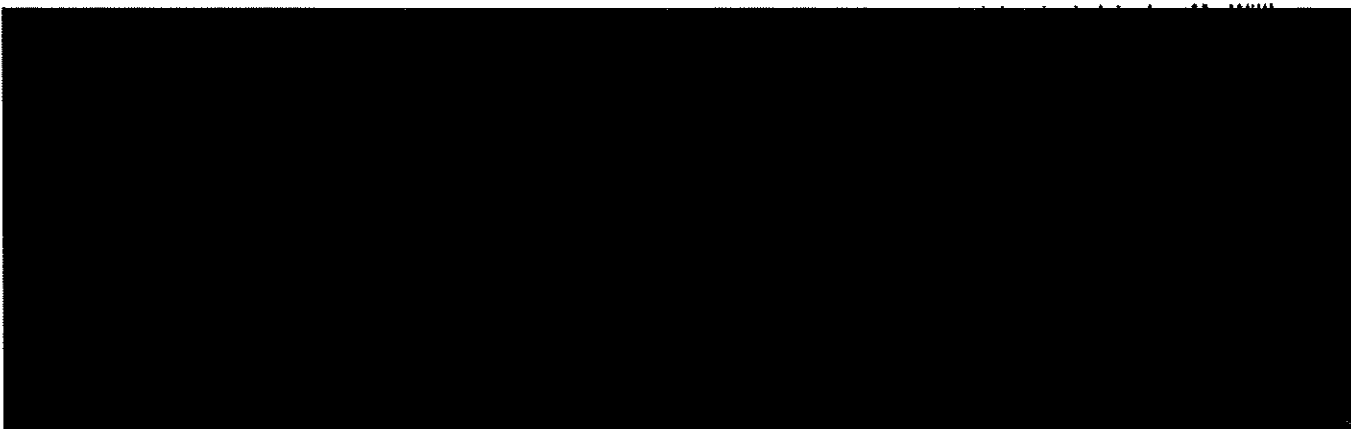
On March 31, 2024, at approximately 9:55 PM, while conducting proactive patrol in the 700 block of Atlantic Blvd, I observed a silver Toyota Camry traveling west on Atlantic Blvd with only one taillight. I followed the vehicle west; I then activated the overhead emergency lights on my marked patrol vehicle and conducted a stop of the vehicle at the intersection of Atlantic Blvd and Atlantic Village. The vehicle came to a stop at the intersection of Atlantic Blvd and Aquatic Dr.

I then made contact with the driver, Jazmyn Woodharen (witness), and explained the reason for the stop. [REDACTED] asked Ms. Woodharen if the vehicle was registered to her, and she stated that the front passenger, Michael Kimmell (suspect), was the registered owner. As the suspect opened the glove box to retrieve the registration for the vehicle, I observed a single dose of Narcan, and a tray commonly used for narcotics within the glovebox. I asked Ms. Woodharen, the suspect, and the backseat passenger, Carlton Williams (witness), if there was any contraband in the vehicle or on their persons, and they all stated there was not.

K9 Ofc. Gray (1243), with the Jacksonville Beach Police Department, arrived on scene to assist during my traffic stop. I advised him I had reasonable suspicion to believe there were illegal drugs inside of the vehicle. K9 Ofc. Gray made contact with the occupants of the vehicle, one at a time, and asked them to exit the vehicle. He advised the registered owner he would be utilizing his police service dog to conduct an open air sniff around the vehicle. The occupants were asked to move to the back of my patrol vehicle for safety reasons while he deployed his police service dog to conduct an open air sniff around the vehicle. K9 Ofc. Gray deployed PSD Bear from his vehicle to conduct the open air sniff. After a brief time, K9 Ofc. Gray put PSD Bear back in his vehicle and then advised me PSD Bear gave a positive alert to the front passenger side door of the vehicle, giving me probable cause to search the vehicle.

At this time, I began searching the vehicle. While searching the front driver's seat and surrounding area, I discovered a black digital scale with white residue (property 11) and 0.1 grams of white rocks in the center console (property 12). While searching the front passenger's seat and surrounding area, I discovered a multicolored bag (property 19) and a brown wooden box. I searched property 19, which contained the following: three clear pipes with white residue (property 13), a brown pipe with white residue (property 14), a silver pipe with white residue (property 15), a clear syringe with unknown residue (property 16), a clear tube with white residue (property 17), and a silver can with white residue (property 18). I searched the brown wooden box, which contained the following: a clear syringe with white residue (property 20), three white straws with white residue (property 21), an orange straw with white residue (property 22), a clear straw with white residue (property 23), a blue straw with white residue (property 24), a red straw with white residue (property 25), a brown glass tube with white residue (property 26), and a clear container with a blue lid with white residue (property 27). While searching the rear left seat and surrounding area, I discovered a black backpack that was propped up against Mr. Williams while he was seated. I searched the backpack, which revealed the following: a purple Crown Royal bag (property 1), 1.1 grams of white powder in a clear plastic bag (property 2), 9.5 grams of white rocks in a clear plastic bag (property 3), 22.4 grams of white rocks in a clear plastic bag (property 4), 7.0 grams of white rocks in a clear plastic bag (property 5), 2.5 grams of white rocks in a clear plastic bag (property 6), 42 0.34 gram pieces of tinfoil containing white powder totaling 14.5 grams (property 7), a clear plastic bag with white residue (property 8), and a clear pipe with white residue (property 9).

I advised all three subjects of their Miranda rights via card, and all three agreed to speak with me.



I field-tested properties 2-9, 13-19, and 20-27 for fentanyl, which all tested positive. I field-tested property 12 for Ketamine, which tested positive.



The suspect was transported to the PTF without incident.
