**Additional Information**

On February 28, 2024 at 3:37pm, a \$19,000 golf cart was stolen from a residential driveway located at 500 Oceanfront in Neptune Beach, FL. The theft, captured on video surveillance, showed an unknown black male and unknown white male walking down the street acting in a suspicious manner. The white male pointed to the golf cart that was parked at the garage entrance of the residence. The black male then walked up the driveway, got into the golf carts driver's seat, and drove away.

A bulletin (NBPB 24-07) of the suspects and golf cart was prepared and disseminated to surrounding law enforcement agencies.

On 04-10-2024, I was contacted by the Jacksonville Sheriff's Office and learned they had a male subject, identified as Javon Bryant (suspect), in custody on unrelated charges and he resembled the black male suspect that stole the golf cart.

The suspect, Javon Bryant, was interviewed in the Auto Theft Office at the JSO Police Memorial Building. [REDACTED]

Writers Note: The keys were left in the golf cart due to it being parked in close proximity to the residence.

During the interview, Bryant was shown a copy of NBPB Bulletin 24-07. [REDACTED]

The interview was audio/video recorded.

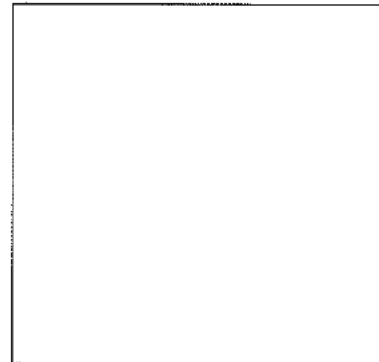
