Santa ride-th **Monthly Report** December 2023

Chief's Message

Happy New Year! The NBPD is excited to ring in a new year with new opportunities and a bright future. We have several big projects in the works to advance the department and ensure public safety. Let's make 2024 the best year yet!

- By the end of this month, the 9mm service weapon transition project will be completed. This will fully convert our agency from our current ageing (~10 to 15year-old) .40 cal Glock pistols to a new 9mm Glock version. These weapons have improved recoil management (resulting in improved accuracy), utilize a more cost-effective 9mm ammunition round, and are equipped with the latest cutting-edge technology. Each service weapon will have a red-dot optic affixed to the top, new flashlights, and new holsters to accommodate the new equipment. This project was grant-funded, with an award of over \$53,000, using a U.S. Department of Justice Assistance Grant.
- Also by the end of this month, the addition of ZimHi, an opioid blocker like Narcan, will be fully implemented to field personnel to add in our staff's toolbox to combat fentanyl-related overdoses and/or emergencies. This product was obtained completely free of charge, through the FL Dept. of Health.
- The NBPD participated in a "Wolf Pack" task force with the Jacksonville Beach Police Department and Florida Highway Patrol as part of the "Celebrate Safely" impaired driver initiative. This campaign was created to help reduce alcoholrelated traffic deaths and injuries throughout the holiday season. Together the taskforce conducted 71 traffic stops resulting in 9 arrests. One of those arrests was a DUI with a charge of armed possession of cocaine/marijuana with intent to sell.
- We are welcoming a new police officer, scheduled to start in January 2024, from the Jacksonville Sheriff's Office. More information, swearing-in, and a bio will be included in next month's report and on our social media platforms. We are still hiring and looking to fill a few more officers' vacancies and would invite anyone to apply. Applications can be found on our website or by emailing joinNBPD@nbfl.us
- There are several other internal activities planned for this year such as the creation of an SOP committee, comprised of supervisors within our department, to review and update policies and procedures. We are also reviewing municipal ordinances for revisions and/or drafting new ones as it relates to Towing Vehicles, Sex Offenders, and Noise Complaints. While these types of tasks can seem mundane, they are vital to ensuring we stay current and adapt to an ever-changing world.


