For a small agency, we are exceedingly busy and constantly striving to find better ways to deliver exceptional law enforcement services. The men and women of the NBPD work hard each day to achieve this goal and without them, Neptune Beach would not be the special place it is. I am beyond blessed to be surrounded by dedicated, committed, and duty-bound individuals.

# Departmental Activities

- On a national and global level, NBPD Staff participated in a conference call recently with Governor DeSantis, FL Attorney General Ashley Moody, and others in reference to the crisis in Israel. The NBPD is closely monitoring the situation and receiving intelligence briefs. We have strategically positioned our officers at our local schools and places of worship while not out on patrol or on calls.
- Our Narcan initiative has been in place for a significant period now. We rolled this out to save lives be it an overdose victim or a fellow-officer. We are now researching a new product known as 'ZimHi'. This is an injectable form of an opioid blocker which is more concentrated and effective than Narcan.
- Our E-bike Safety Campaign is still a top priority and ongoing. We are confronting the
  problem in two parts: education and enforcement. To date, we have given lectures at
  Neptune Beach Elementary School and Beaches Chapel School and conducted
  numerous directed-patrol enforcement campaigns to curb aggressive E-bike driving.
  Since August, we have conducted 23 operations, totaling over 18 hours. We issued 19
  warnings and made one arrest for a stolen tag.
- We are currently hiring for Police Officers, with two open vacancies. We have an
  excellent and highly talented pool of candidates several of which have experience
  with other agencies. It is always refreshing to see officers from other departments
  want to come work for the NBPD. It truly speaks to the health of our organization.
- Along with several other recipients, the NBPD celebrated a grant award of a new UTV from the Firehouse Subs Public Safety Foundation. This new equipment was obtained at a zero-cost to the taxpayers and will help our agency serve and protect the citizens and visitors, alike. When they ask if you'd like to 'round up', just know we have seen that money flow back into public safety agencies and are so appreciative of their efforts.
- The Mobility Management Division has integrated well under the Police Department. New signage was recently placed in front of City Hall and the west lot near the Police Department on 2nd St. Adding additional parking spots to better serve the Beaches Town Center have been identified and are in the works. The Parking Ambassadors recently received a small increase in pay to stay competitive and we recently hired a new employee. We are still looking for an additional employee who is dedicated and of high moral character to join us.






