Additional Information

On 9/8/2023 at 10:47 PM while working off duty at 117 1st Street I was flagged down by Witness #1 in reference to an individual inside the establishment with a firearm.

Witness #1 stated that he was inside Pete's Bar when the suspect approached him. While speaking about the suspect's recent shoulder surgery, the suspect raised his shirt to show Witness #1 a scar on his shoulder. Upon raising his shirt, Witness #1 noticed a firearm (Property #1) inside the suspect's waist band. When the suspect noticed Witness #1 observing the firearm, he pointed to it and stated he was "in blackwater" and referred to the firearm as his "side piece". The witness then left and notified law enforcement.

Contact was made with the listed subject inside Pete's Bar consuming alcohol. The suspect was escorted outside the establishment and detained. Listed Property #1 was located in the suspect's right-side waist band. Post Miranda, the suspect stated that he was unaware he was not allowed to carry inside establishments licensed to dispense alcohol. While speaking with the suspect he had red and watery eyes and he spoke with a distinctly slurred speech pattern.

It should be noted law enforcement personnel was flagged down in reference to the suspect earlier in the evening for a verbal altercation. A receipt located on the suspect showed 3 Pabst Blue Ribbon beer purchased at 10:39 PM. Witness #1 provided a written statement. The listed property was entered into the Neptune Beach Property Room.

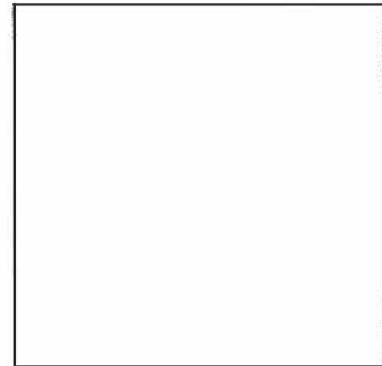
